V Validity Period of the Bid

VIII Criteria for selection of the most advantegous bid:

The criteria for selecting the most advantegous bid are:

The contracting authority will select the most economically advantageous bid, applying a cost-effectiveness approach, based on the following criteria:

- The ratio of the price, quality and reference list (30/60/10)

The Commission for conducting the procurement procedure shall evaluate the bids based on the criterion of the ratio of price, quality and payment terms by applying the relative (proportional) method, as follows:

- 30 points shall be awarded for the lowest offered price (C),
- 60 points shall be awarded for the best offered quality (K1 + K2),
- 10 points shall be awarded for the reference list with the highest number of contracting authorities.

The total number of points shall be calculated as follows:

Total points = points for price (C) + points for quality (K1 + K2) + points for payment terms (PT)

1. Lowest Offered Price (C) (30 points)

The price parameter shall be evaluated as follows:

The lowest offered price shall receive the maximum of 30 points.

Points for all other bids shall be calculated proportionally in relation to the lowest offered price, according to the following formula:

Number of points (C) = (Lowest offered price / Offered price) \times 30 points

2. Quality (K1 + K2) (60 points)


The quality parameters K1 and K2 shall be evaluated in the following manner:

Quality (K1)

The longest warranty period offered receives the maximum number of points, 30. Points for other bids shall be calculated proportionally in relation to the longest warranty period offered, according to the formula:

Number of points (K1) = (warranty period offered / longest warranty period offered) \times 30

The warranty period is expressed in months.



The evaluation of bids under the quality parameter related to the warranty period shall be carried out in relation to the conditions offered that are more favourable, i.e. better than the required condition.

Quality (K2)

Parameter "quality (K2) – "Quality K2 – Technical characteristics: construction quality, pump characteristics, return flow volume" shall be evaluated as follows: A maximum of 30 points under this parameter shall be awarded to the Bidder offering the best construction quality, pump characteristics, and return flow volume, while other Bidders shall receive less points proportionally according to the following formula:

Number of points (K2) = (quality of construction, pump characteristics, return flow volume / best offered quality of construction, pump characteristics, return flow volume) \times 30.

3. Reference List (RF) (10 points)

The highest number of entries on the reference list with which the Bidder has had business cooperation and completed contracted works amounts to 10 points.

The highest number of contracting authorities/service users listed in the reference list receives 10 points. Points for the other bids are calculated according to the following formula:

(the highest number of offered / listed contracting authorities from the reference list / the lowest number of offered / listed contracting authorities from the reference list) \times 10


